**1. General Description**

The specification is a transmissive type color active matrix liquid crystal display (LCD) which uses amorphous thin film transistor (TFT) as switching devices. This product is composed of a TFT-LCD panel, driver IC, a touch panel and a backlight unit.

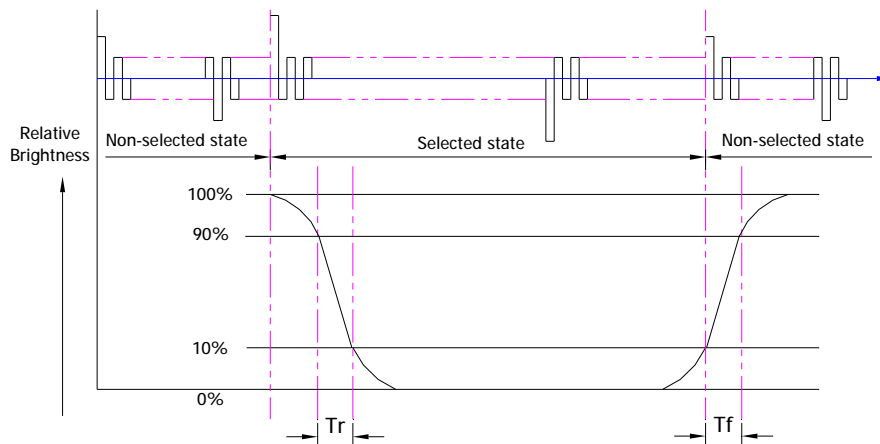

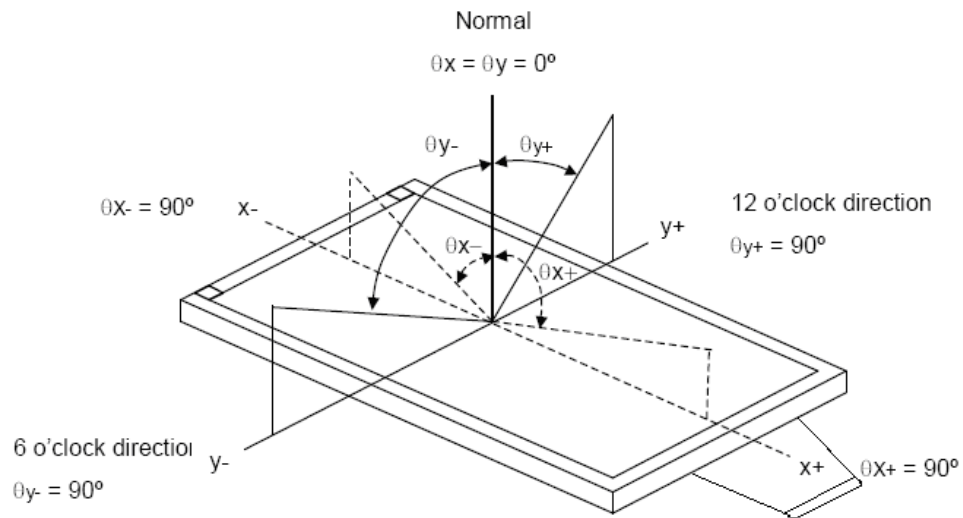

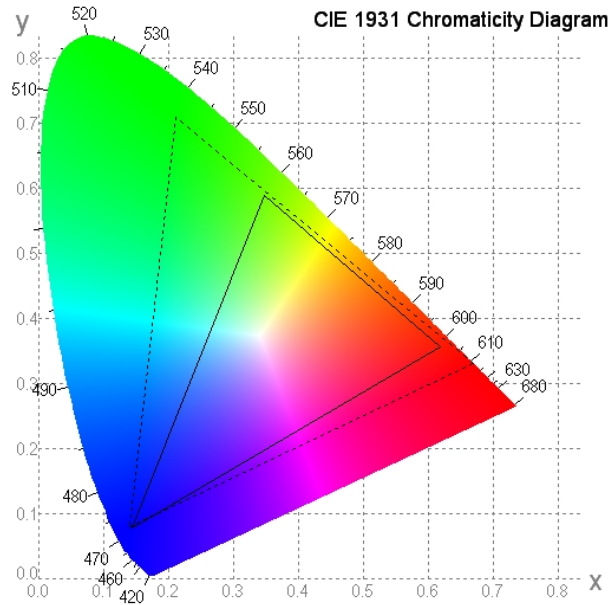

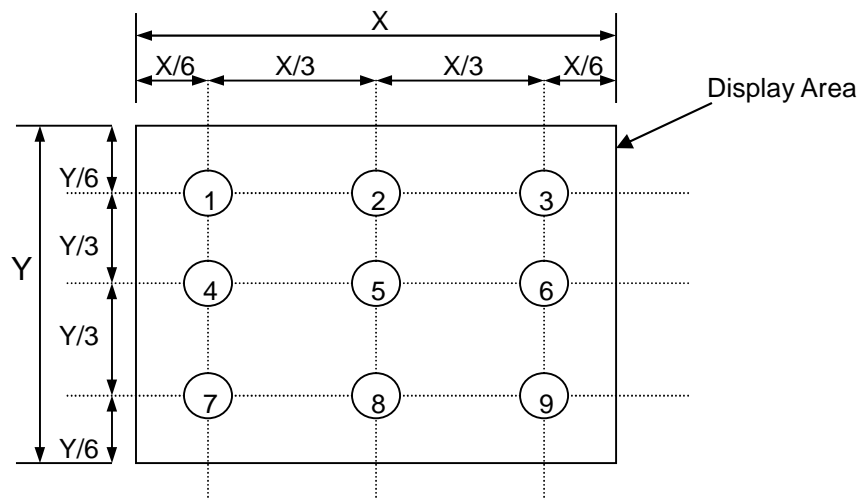

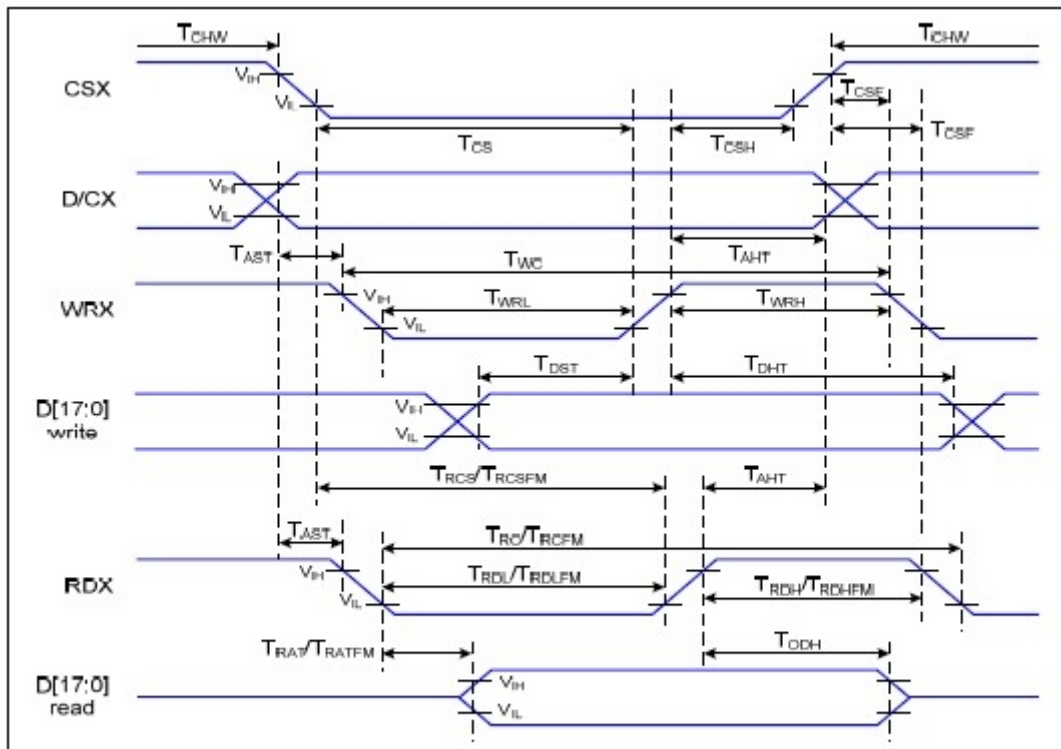


Figure 1 Parallel Interface Timing Characteristics (8080 Series MCU Interface)

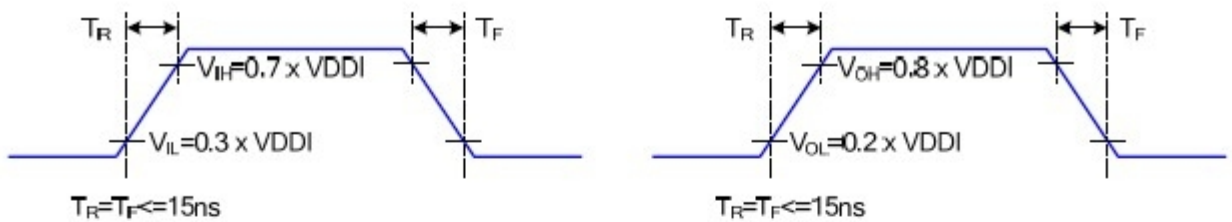


Figure 2 Rising And Falling Timing for Input And Output Signal

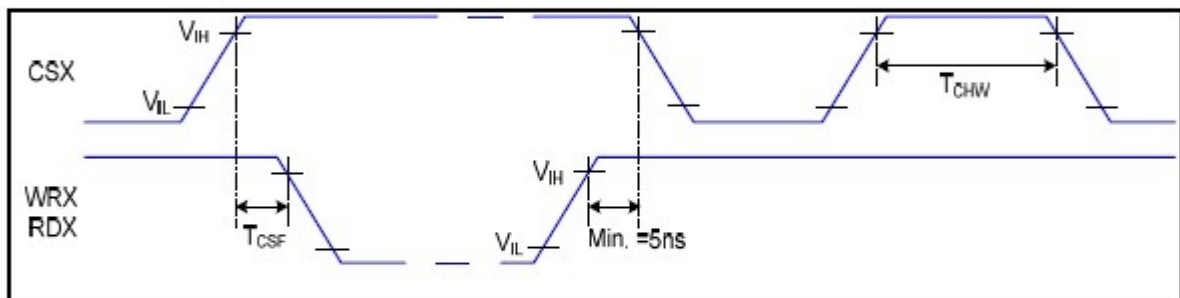


Figure 3 Chip Selection (CSX) Timing

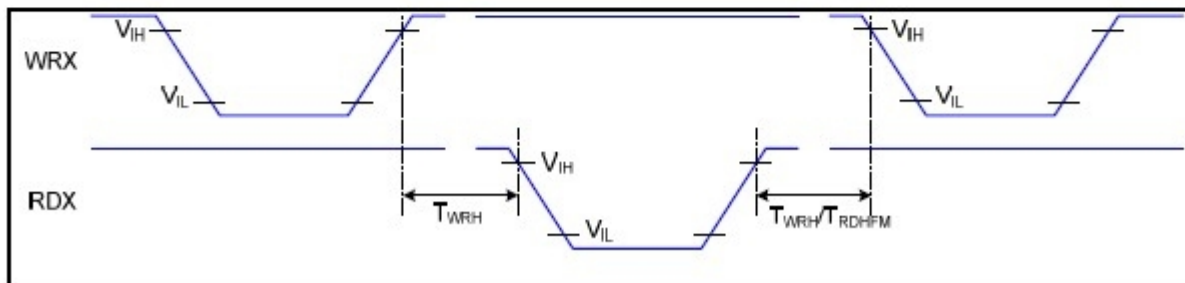


Figure 4 Write-to-Read And Read-to-Write Timing

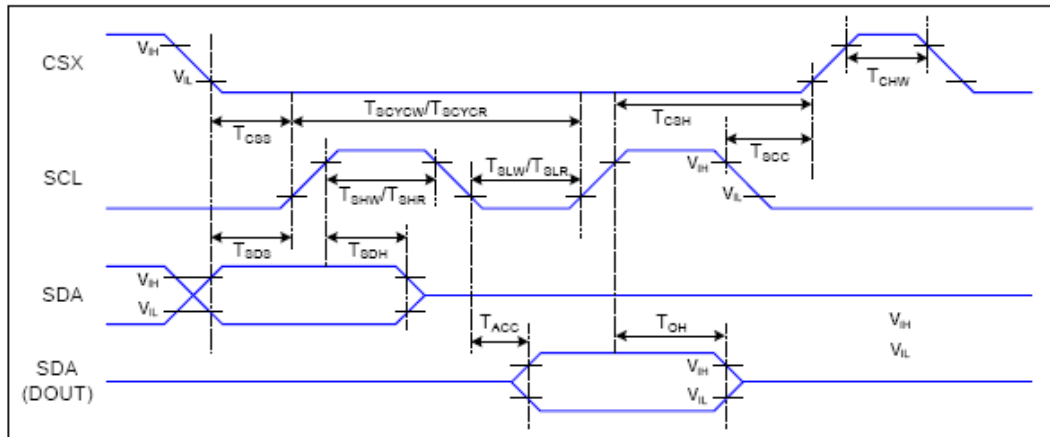


Figure 6 3-line Serial Interface Timing

#### 11.2.2. Sampling Criteria:

Visual inspection: AQL 1.5%

Electrical functional: AQL 0.65%.

#### 11.2.3. Reliability Test:

Detailed requirement refer to Reliability Test Specification.

### **11.3.Nonconforming Analysis & Disposition**

#### 11.3.1. Nonconforming analysis:

11.3.1.1. Customer should provide overall information of non-conforming sample for their complaints.

11.3.1.2. After receipt of detailed information from customer, the analysis of nonconforming parts usually should be finished in one week.

11.3.1.3. If cannot finish the analysis on time, customer will be notified with the progress status.

#### 11.3.2. Disposition of nonconforming:

11.3.2.1. Non-conforming product over PPM level will be replaced.

11.3.2.2. The cause of non-conformance will be analyzed. Corrective action will be discussed and implemented.

### **11.4.Agreement Items**

Shall negotiate with customer if the following situation occurs:

11.4.1. There is any discrepancy in standard of quality assurance.

11.4.2. Additional requirement to be added in product specification.

11.4.3. Any other special problem.

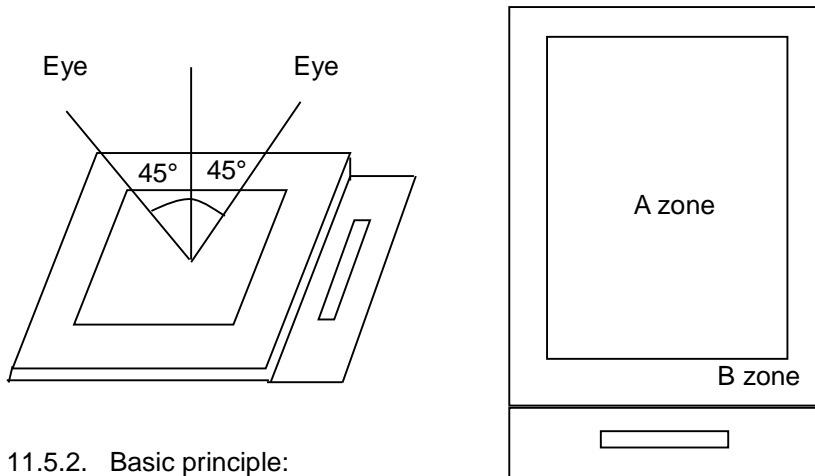
**11.5. Standard of the Product Visual Inspection**

11.5.1. Appearance inspection:

**14.5.Operation**

- 14.5.1. Do not drive LCD with DC voltage
- 14.5.2. Response time will increase below lower temperature
- 14.5.3. Display may change color with different temperature
- 14.5.4. Mechanical disturbance during operation, such as pressing on the display area, may cause the segments to appear “fractured”.
- 14.5.5. Do not connect or disconnect the LCM to or from the system when power is on.
